Thank you for your interest in participating in the **2024 Broome Art Trail!** This event is an open weekend of studios, galleries, and creative sites across Broome County where artists can showcase and sell their artwork. To participate in this event artists must be available to exhibit/sell both **Saturday, September 21, 2024 10AM-4PM and Sunday, September 22, 2024 11AM-4PM.**

### **Registration Instructions**

#### **Are You An Artist *With* A Studio?**

If you are an artist with an independent studio (whether at home or elsewhere) when completing the 2024 Broome Art Trail Registration Form you register under the professional name and address associated with your studio.

#### **Are You An Artist *Without* A Studio?**

Artists are expected to independently secure the exhibition site (studio, gallery, etc.) before completing registration. It can be a home studio, a gallery, or a creative site that would be available to showcase your work. If possible Artists are encouraged to establish working studios from which to exhibit and possibly demonstrate their artistic craft.

Also, please note that artists are wholly responsible for the equipment needed to display their work and some host sites will not allow artists to hang on their walls.

## **2024 Categories of Work Accepted**

The following categories of work will be accepted for the 2024 Broome Art Trail. Artists are welcome to exhibit multiple mediums of work.

- Painting (watercolor, encaustic, oil, acrylic, etc.)
- Drawing (charcoal, graphite, colored pencil, etc.)
- Printmaking
- Photography and Digital Arts (prints and commissioned work)
- 3D: ceramics, wood, glass, metal, fiber, mosaic, sculpture
- Mixed Media
- Collage
- Written work (Zines, published manuscripts, etc.)
- \*Performing arts (Original plays, stand-up comedy performances, music performances, etc.)

\*Please note that any performances or other artistic demonstrations should be free for the community to attend

## **Additional Participation Information**

- The 2024 Broome Art Trail will be in-person only event, with artists and locations listed on our website ([www.broomearts.org/in-the-community/broome-art-trail](http://www.broomearts.org/in-the-community/broome-art-trail)).
- BCAC will provide a centralized website featuring all of the artists' work and map of the venue sites.
- Artists should plan to collect some data for reporting to BCAC via our followup participant survey (attendance, sales, visitors from outside the county, etc.).

- BCAC does not take commissions on any sales made through Broome Art Trail.
- Venues, artists, and musicians participating in the 2024 Broome Art Trail understand that BCAC does not provide insurance coverage for Broome Art Trail events that happen at an artist's home, an artist's studio, or any other locations the artist uses. Any interactions between the artists and the general public is between those two parties and does not involve BCAC. This includes injury, damage, or any other type of calamity or complaint. Artists agree to hold harmless BCAC, its employees, officers, volunteers and directors from any and all claims, actions, demands or other proceedings for any actual or alleged injury to persons or damage to property for any reason whatsoever and/or arising out of any act or omission of artist and their premises, or other locations.

Please note that works that are easily transported, functional, and easy to take home do the best for sales. However, we encourage all types of work to be featured in the Broome Art Trail.
